After leaving Switzerland in 2018 to pursue her musical ambitions in London, LAGIOIA refined her craft at the prestigious BIMM School and built a dedicated following through energetic live performances. Upon her return, she has graced the stages of renowned festivals such as Gurten Festival, Moon & Stars, RADAR, and Seaside. Her track "On and On" gained recognition at m4music's Demotape Clinic and was featured on BBC Introducing Kent. With the release of her debut EP "BRUTALLY HONEST", LAGIOIA is set to embark on her first Swiss tour in spring 2025.
